

A RESOLUTION ADOPTING THE SCHEDULE OF FEES AND CHARGES
FOR THE FINANCE AND ADMINISTRATION DEPARTMENT
OF THE CITY OF STATESBORO, GEORGIA

THAT WHEREAS, the City of Statesboro operates a Finance and Administration Department, which among other things is responsible for administration of the Municipal Court; billing and collecting utility accounts; making copies of official records on request; and administering the property tax collection, and business license and alcohol license provisions of the Municipal Code; and

WHEREAS, in order to finance some of these operations, the City has previously and must continue to impose various fees and charges; and

WHEREAS, the City Manager and Finance Director have recommended a schedule of fees and charges, and the Mayor and City Council upon careful review wish to implement said schedule of fees and charges;

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Statesboro, Georgia this 6th day of February, 2007 as follows:

Section 1. That the document entitled "Schedule of Fees and Charges for the Finance and Administration Department of the City of Statesboro, Georgia", attached hereto and incorporated into this Resolution by reference, is hereby adopted and approved as the fees and charges authorized to be charged by the department.

Section 2. That any provision of any ordinance or resolution, or administrative policy in conflict with this schedule is hereby repealed to the extent of any such conflict; and the provisions of this Resolution shall take precedence in determining the fees and charges to which they apply.

Section 3. That this Resolution shall be and remain effective from and after its date of adoption.

Schedule of Fees and Charges for the Finance and Administration Department
of the City of Statesboro, Georgia
February 6, 2007

Fees for Open Records Requests:

In accordance with the Official Code of Georgia Annotated, the charges for records search, retrieval, and reproduction shall be:

- a) Time to search and duplicate records: First 15 minutes—no charge. After the first 15 minutes the customer shall be charged at the hourly rate of the personnel required to complete the search and copy the records.
- b) The cost for copies will be \$.25 per page.
- c) Audio tapes will be made if the customer provides the tape. The only charge would be for the time involved, charged under a) above.

License and Tax Fees:

Real and Personal Property Taxes

- a) The millage rate shall be set by the Mayor and City Council annually.
- b) A Late Penalty shall be applied 90 days after billing, which is 10% of the tax amount applied once.
- c) Interest Penalties shall be applied 90 days after billing, and each month thereafter that the taxes remain unpaid, at the rate of 1% per month on the tax amount.
- d) FIFA Fee is \$10.00.

Occupational Taxes

- a) Application Fee \$15.00
- b) Regulatory Fee \$15.00

Occupational Taxes are based upon 6 Tax Classes as follows:

Alcohol Licenses renew each July 1st and are pro-rated after December 31st of each year per the ordinance.

1. UTC Code means the Uniform Traffic Citation Code.

2. Bond AMT. Means the amount of the bond to be posted, and possibly forfeited.
3. MAND. CT. Means that a mandatory court appearance is required. If MAND CT is in the column, it means an appearance in Municipal Court. STATE means an appearance in State Court, and SUP. means an appearance in Superior Court.
4. DBI means to be determined based upon the incident and its circumstances, ie., at the Judge's discretion.
